All vendors agree to indemnify and save the Tremont Arts & Cultural Festival, Merrick House, Tremont West Development Corporation, its volunteers and staff, and the City of Cleveland harmless from any loss, costs, damages and other expenses, including attorney's fees, suffered or incurred by Tremont Arts & Cultural Festival by reason of vendor's negligence or intentional misconduct or that of its employees, agents and associates; provided that, the vendor shall not be liable for nor required to indemnify Tremont Arts & Cultural Festival, its volunteers and staff, and the City of Cleveland for their negligence or that of their servants, agents, employees or associates. It is required that each vendor carry his or her own personal and product liability insurance. Furthermore, vehicle liability insurance is required to cover any damage caused.
